Ohio Association of Foodbanks Awarded \$1.95 Million Federal Navigator Grant

Media Statement from Lisa Hamler-Fugitt, executive director for the Ohio Association of Foodbanks:

“We are thrilled to announce that the Ohio Association of Foodbanks—along with a network of strategic consortium members—was awarded a federal Navigator grant by the Centers for Medicare and Medicaid Services (CMS). This approximately \$1.95 million grant will allow us to raise awareness about the federal-facilitated Health Insurance Marketplace and connect Ohioans with assistance in enrolling in plans in the Health Insurance Marketplace beginning this fall.

“Through our existing network of thousands of community-based organizations, and in partnership with our strategic partners, we look forward to making sure that those Ohioans uninsured or underinsured and struggling to afford health care have the help they need to make informed decisions about their health insurance options. Our project will raise awareness about the Marketplace through many avenues and will be carried out in partnership with a consortium made up of regional and local organizations knowledgeable about the specific needs of the uninsured and underserved Ohioans in their geographic service area.

“As the home of The Ohio Benefit Bank, we have worked in partnership with the State of Ohio and many other state and federal agencies to connect Ohioans with health care programs and other services for many years. We feel that serving as Navigator in Ohio is a natural extension of our work to provide food and other important resources to people in need. We thank CMS for entrusting us with these dollars and we are excited to begin this important outreach in the state of Ohio.”
